# India eVisa Application

**New Delhi, Delhi Jul 12, 2024 (IssueWire.com)** - India provides two types of visas for its foreign travelers. These traditional paper visas are meant for long stays in the country. The other one is the online visa which is for shorter stays and can be applied online. Getting the Indian eVisa is easy and can be quickly done in three simple steps. Getting the **INDIAN VISA FOR DENMARK CITIZENS** can be obtained by submitting the required documents, paying for the visa, and receiving the approved visa at the given email address. The Danish passport must be regular or ordinary for this visa, as a diplomatic passport is not allowed. The **INDIAN VISA FOR NETHERLANDS CITIZENS** is suited for people who are coming to the country for a short period. The eVisa application must be submitted before 4 days of arriving at the Indian borders. Applying for the Indian eVisa can be done online, without ever paying the nearest Indian embassy or consulate a visit. The only requirement for getting the visa is a stable online connection. Understanding the dates on the Indian eVisa is extremely important for any foreign national coming to the country. The Date of Issue on the e-Visa is the date when the Indian Immigration Authority issued the e-Visa. The other one is the Date of expiry or the **INDIAN EVISA EXPIRY DATE** on e-Visa which is the last date by which the online visa holder must enter the country. Another date is the last day of stay in India which refers to the last day beyond which the visa holder can no longer stay in the country. The **INDIAN VISA FOR PORTUGUESE CITIZENS** is given for three purposes of arrival. These three are tourism, business, and medical reasons for visit.
