and fraud. Finch, initially interviewed by Laura Jaramillo Bernal of Mariworks LLC and nuEra Cannabis, exposes the company's unethical practices in pursuit of profit. nuEra Cannabis, led by CEO Bob Fitzsimmons, used Finch as a pawn to challenge the constitutionality of JB Pritzker's Social Equity program, causing delays and hindering minorities from obtaining licenses. Finch, a bisexual Black veteran, is committed to promoting inclusivity in the cannabis industry. The case, filed in Cook County Circuit Court (2023L008973), seeks to hold nuEra Cannabis accountable and seeks compensation for damages. A class action exploratory group has formed to address allegations of sexism, fraud, and racism within the company seen on indeed. With little to no legal updates from nuEra Cannabis, the plaintiffs recovered evidence from a hacking attempt, prompting further federal legal investigations.
