What Is a Veteran Disability Benefit?

Veteran disability benefit is a tax-free monthly payment provided by the U.S. Department of Veterans Affairs to veterans suffering from disabilities resulting from their military service. Disabilities can be physical, mental, or a combination of both.

To be eligible for veteran [disability benefits](#), a veteran must show substantial evidence, such as medical records and other documentation, to show that the condition was caused or worsened during their active military service. The amount the veteran is going to receive is decided on the disability rating based on the severity of the condition.

What Are the Conditions Covered by Veteran Disability Benefits?

Chronic Diseases: such as arthritis, diabetes, or hypertension, if diagnosed within one year of active duty release

Heart Conditions: such as coronary artery disease, heart arrhythmia, or heart murmur

Hearing Loss: such as tinnitus, which is characterized by hearing sounds that don't exist, such as ringing in the ears.

Mental health conditions such as anxiety, depression, and mental or physical health conditions related to military sexual trauma (MST), post-traumatic stress disorder (PTSD), and traumatic brain injury (TBI).

Other conditions: such as chronic back pain, breathing problems, scar tissue, loss of range of motion, ulcers, or cancers caused by contact with toxic chemicals

What Are the Types of Disability Benefits?

Disability Compensation: As explained above, it's a monthly compensation to veterans who have a service-connected disability. The amount depends on the severity of the condition the veteran is suffering from.

Disability Pension: For veterans with low income and limited resources who are permanently and disabled from non-service-connected conditions. Eligibility is based on financial need rather than service connection.

Special Monthly Compensation (SMC): Additional payments for veterans who have severe disabilities or specific conditions that warrant extra support, such as the loss of use of a limb or blindness.

Veterans Readiness and Employment (VR&E): Provides services to help veterans with service-connected disabilities prepare for, find, and maintain suitable employment.

Dependents and Survivors Benefits: Includes benefits for family members of deceased veterans, such as Dependency and Indemnity Compensation (DIC) and educational benefits.

What Is the Procedure to Apply for Veteran Disability Compensation?

- Determine Eligibility

Before applying, ensure that you are eligible for veteran disability benefits.

Service-Connected Disabilities: For disability compensation, your condition must be connected to your military service. This means it was caused or aggravated by your service or by those whose existing condition is made worse by being in the service.

Income and Financial Need: For disability pension, your income and net worth must fall below certain limits.

Gather The Required Documentation.

Collect all necessary documentation to support your application:

Medical Records: Detailed records from your healthcare providers, including diagnosis, treatment history, and any service-related injuries or conditions.

Service Records: Your DD Form 214 or other discharge papers outline your military service and discharge status.

Income and Financial Records: For pension benefits, provide documentation of your income, assets, and household expenses.

- Complete The Application.

You can apply for [VA disability benefits](#) online using the VA's eBenefits portal, by mail, or in person at a VA regional office. The application process involves providing detailed information about your disability, military service, and personal circumstances.

- Submit The Claim.

Here is what [Disability Claims Process](#) entails and below are the following ways to submit the claim:

Before leaving military service, apply through the pre-discharge program before leaving service.

Apply with an accredited representative. It's best to work with an accredited representative or agent to assist them in compiling a fully developed claim for submission.

Visit a VA Regional office where you will get assistance from trained staff.

- Attend a Compensation and Pension (C&P) Exam

The VA may require you to attend a C&P exam to evaluate the severity of your disability and its connection to your military service. This exam is conducted by a [VA healthcare](#) provider or a contractor.

Be honest and thorough during the exam to ensure an accurate assessment.

- Follow Up on Your Application

After submitting your application, regularly check its status. You can do this online through the VA's eBenefits portal or by contacting the VA directly. Be prepared for requests for additional information or documentation.
