The requirements include a digital copy of the traveler's passport's primary (biographical) page, a copy of the visitor's most recent passport-style color photo, and a return or next flight ticket abroad. The passport must be valid for a minimum of six months after entry into India, otherwise, a new passport must be obtained.
