- The price of VEEC (Victorian Energy Efficiency Certificates) energy certificate price at the time of installation.
- Location of the installation (how far your home/business location is from the office address of the accredited installer)?
- Installation and labour costs.
- Administrative costs incurred during rebate processing.
- The specific split system air conditioner unit selected.
- Number of indoor units installed

Who are eligible for aircon rebate in Victoria?

Homeowners and businesses in Victoria are entitled to a rebate of up to \$9000 for a split-system air conditioning system upgrade carried out under the VEU program. To qualify for this rebate, the following eligibility conditions must be met:

- The building construction must have been completed more than two years prior to the upgrade.
- The property must be located within the Victoria state
- The old HVAC unit must be connected to the building electrical circuit.

Rebates are also available to renters; however, they must negotiate terms with their property owners before proceeding with an air conditioning upgrade.

How to apply?

To apply for the split-system air-conditioner rebate:

1. Complete the rebate sign-up form on our website.
2. Email us your property ownership document and address details.
3. Our licensed electricians will assess your existing system and replace it with a new reverse cycle split system air-conditioning unit.

We will submit the rebate application on your behalf. Once approved, you will receive your rebate as discounts applied directly to your installation costs.
