If you are wondering **HOW TO APPLY a TURKEY VISA FROM INDIA**, the answer is that no traveler from eligible countries needs to get a traditional Turkish paper visa anymore. Instead, they can go to the official government website and apply for an online Turkish visa. This is under the country's visa waiver program which gives travelers an electronic travel authorization or travel permit to visit Turkey for a period of up to 90 days. The **TURKEY VISA FOR BHUTAN CITIZENS** is mandated for short stays. The eVisa entitles Bhutanese travelers to a continuous stay of 30 days with a single entry. The Turkey e-Visa is valid only when the purpose of travel is tourism or business. However, if the maximum stay exceeds 30 days, legal actions would be taken against the traveler. Bhutanese citizens who are planning to stay in the country for more than 30 days can opt for the traditional Turkish paper visa instead. The **TURKEY VISA ELIGIBILITY CHECKER TOOL** tells foreign citizens whether they are eligible to apply for the eVisa and travel to the country based on that. On the checker tool page, travelers have to choose their country from the dropdown and the tool will check if their country is eligible for the Turkish eVisa. The **TURKEY VISA MISTAKES TO AVOID** include overlooking the instructions and making errors in the application. Another mistake that would reject the application would be to not provide accurate data

regarding travel details, contact information, and passport details, including the purpose of the visit.
