What is India eVisa (or Indian Visa Online)

New Delhi, Delhi Dec 26, 2024 ([Issuewire.com](https://www.issuewire.com)) - Visiting India requires a valid visa and passport for every foreign citizen. The country provides two types of visas, a traditional paper visa, and an online visa. This online visa is part of the Indian government's visa waiver program. To obtain this eVisa, foreign travelers no longer need to visit the nearest Indian embassy or consulate. They can apply and obtain the visa from the comfort of their homes with just a stable internet connection. To get **AN VISA FROM Côte d'Ivoire**, foreign citizens must be from the eligible countries. They also need a valid passport with a minimum of 6 months of validity remaining from the date of application. The passport must also have two blank pages to be stamped by the immigration official. Getting an **EXPRESS INDIAN VISA** has made traveling to the country easier and more accessible. When applying for the Indian eVisa, there are five subtypes that foreign travelers can choose from. These are e-Tourist Visa is for touring and visiting friends or family, an e-Business Visa, an e-Medical Visa that is designated for any type of medical care, an e-Medical Attendant Visa, and an e-conference Visa that allows the holder to participate in any conference, a seminar, or workshop held in India. The **INDIAN VISA PROCESSING TIME** is very less which makes traveling using the eVisa much more convenient. There is a 30-day Indian tourist e-visa that allows double entry and is non-extendable. To avoid **FINE FOR OVERSTAY IN INDIA**, applicants are advised to check the details of the visa they are applying for beforehand. If the eVisa status is not updated applicants do not need to worry.
