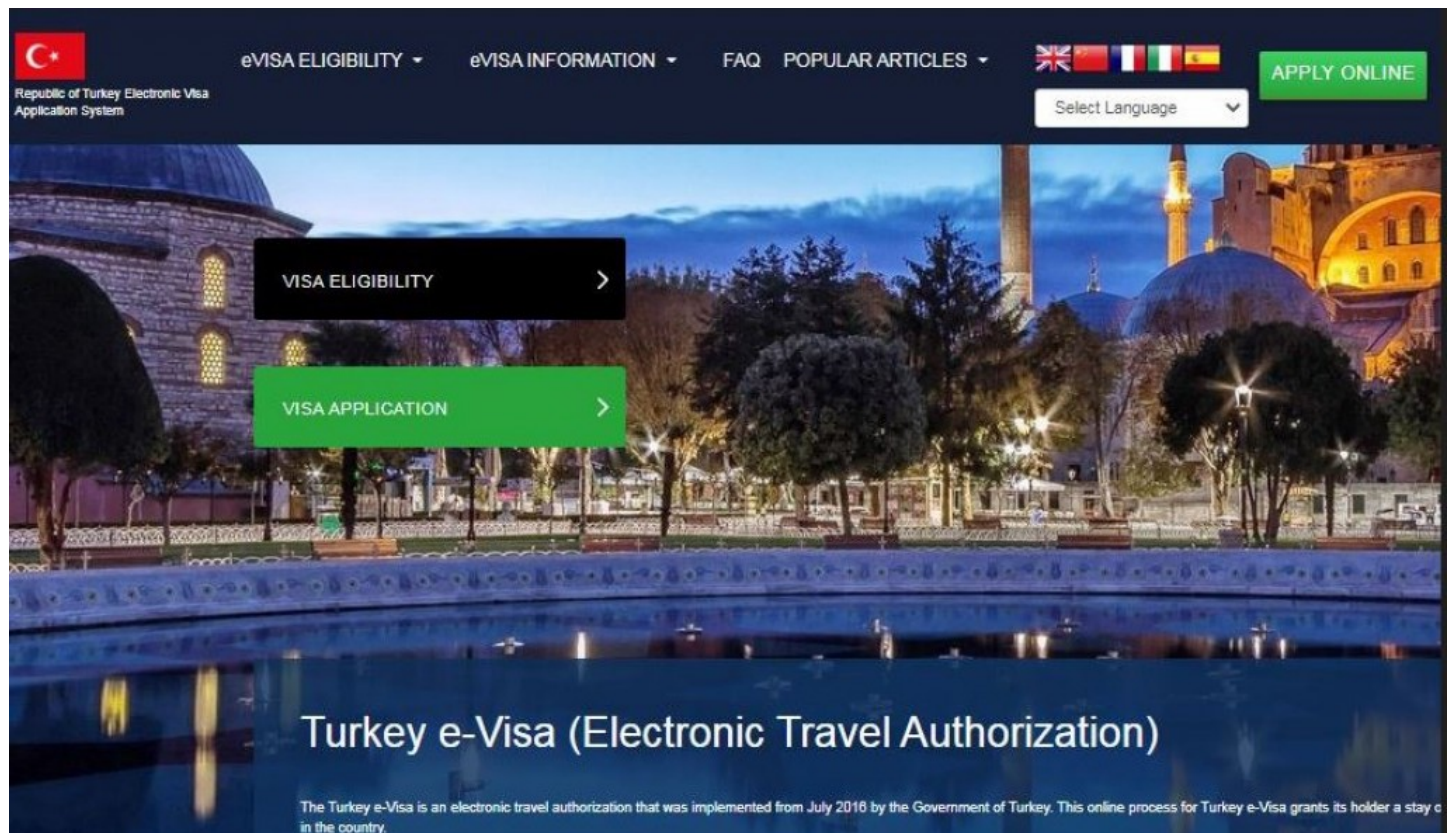


Turkish eVisa Makes It Easier to Travel in A Hassle-free Manner



Istanbul, Turkey Dec 12, 2024 (IssueWire.com) - Turkey offers a new visa waiver program where foreign travelers from eligible countries can come to the country without a traditional paper visa. This eVisa can be applied for and obtained online. The essential **TURKEY VISA DOCUMENT REQUIREMENTS** include a passport that is currently valid, has at least one blank page, and has a minimum of six months remaining from your intended arrival date. Additionally, a working email account to receive your eVisa and related communications, and a credit or debit card (PayPal, American Express, MasterCard, Maestro) to cover the cost of the visa. There are only two **TURKEY VISA TYPES**, a Single-entry eVisa, and a Multiple-entry eVisa. The countries that are eligible for a multiple-entry visa are - Antigua and Barbuda, Bahamas, Barbados, Canada, the United States, and the United Arab Emirates. A Turkish eVisa is only valid for specific activities. Such as - tourism, business, cultural events, sporting activities, conferences, fairs, or exhibitions. The first step would be to fill out the application form with the right data. After that, the applicant must upload the required documents, make the visa payment, and submit the final application. The **TURKEY VISA FOR AMERICANS** avails the opportunity for Americans to stay in the country for

90 days. If the Turkish adventure requires more than 90 days, then the traveler needs to apply for a Turkey residence permit or investigate long-term visa options for work or study. Otherwise, travelers can exit Turkey and re-enter later. The US citizens can stay in the country as tourists for 90 days maximum within a period of 180 days. A very common mistake is applying for a Turkey e-visa with a passport that is either expired or close to expiring. The solution is choosing a passport that has a validity of a minimum of six months. Preventing the mistakes can be done by double-checking all information, and selecting the right visa type before submitting the application form.
