

Turkish eVisa Offers Safer and Faster Entry to Turkey



Istanbul, Turkey Dec 5, 2024 ([Issuewire.com](https://www.issuewire.com)) - The Ministry of Foreign Affairs of the Republic of Turkey has started a new program called the Visa Waiver program to make traveling to the country easier. The country issues two visas, a traditional paper one and an online one. The visa waiver program allows foreign travelers from eligible countries to come to Turkey with an eVisa. The eVisa application can be submitted and obtained online. Visiting the nearest embassy or consulate and standing in line for hours is no longer a need to submit a Turkish visa application. The **TURKEY VISA FROM PALESTINE** is completely online and the visa approval will also be sent via email. The **TURKEY VISA FROM SRI LANKA** can be used for arrival to the country by land, sea, or air. Sri Lankan citizens can stay for up to 30 Days on Turkey e-Visa. There are multiple visit reasons that travelers can use to apply for the Turkish eVisa including Business, Tourism, and Transit visits. All citizens applying for the eVisa must be 18 years of age or over. Otherwise, they need a parent or a legal guardian on their behalf to apply. The **TURKEY VISA FROM YEMEN** must be applied using only an Ordinary Passport, not a Diplomatic one. Yemeni citizens only require a valid email address and Debit or Credit card to apply for Turkey eVisa. Applying for a **Turkey Visa for Indian Citizens** online is easy, quick, and can be completed within a few minutes in three simple steps. The first step is about filling out the application form and submitting all the required documents. The second step requires the applicants to pay for the visa application and

in the third step, the visa approval will be sent directly to the applicant's email address. Know more details at: <https://www.turkish-visa.org/turkey-visa-eligibility/indian-citizens>. The **TURKEY VISA FROM LIBYA** is approved within 24 - 48 hours maximum. Duration of stay can be thirty (30) days or ninety (90) days depending on the applicant's nationality.
