## Use Turkey eVisa to Secure a Safe and Hassle-free Journey



Istanbul, Turkey Dec 12, 2024 (Issuewire.com) - Traveling to Turkey for a short stay is easier now with the government's new visa waiver program. The Government of Turkey has started a new visa waiver program where foreign travelers can apply for an eVisa from the comfort of their homes. They no longer need to visit the nearest Turkish embassy or consulate to apply for a traditional paper visa. Instead, they can complete the entire application process and receive the visa by mail from their homes, with a stable internet connection. The TURKEY VISA FOR BANGLADESHIS allows a 30-day stay within a 180-day validity period. It is suggested to make the application at least 72 hours ahead of the designated flight. Despite age, every foreign traveler from eligible countries needs to apply and get an eVisa before coming to Turkey. This includes kids, children, or minors traveling with their parents. The **TURKEY VISA FOR CHILDREN** application for children might slightly vary, so travelers are advised to understand the eligibility, procedures, Turkey e-Visa requirements, and application process for children. The eVisa is only applicable if the traveling is done with a motive of tourism or business. The **TURKEY VISA FOR SOLOMON ISLAND CITIZENS** requires minimal paperwork and an easy application process to save time and effort. The approval is done quickly, within 2-3 business days. However, the duration of the travel should not exceed 30 days. The applicants are eligible for only a single time entry within the validity period which is 180 days. The Tukrey eVisa is applicable for foreign travelers, but only from eligible countries. There are two types of **TURKEY VISA ELIGIBLE COUNTRIES** - Conditional countries and Standard countries. The Conditional countries can get the eVisa, but there's a specific requirement. The list contains Afghanistan, Bangladesh, Egypt, Equatorial Guinea, Palestine, etc. On the other hand, the Standard Countries have a more straightforward process. The only requirements to get a **TURKEY VISA FOR CAPE VERDE CITIZENS** are a working email address, a credit or debit card to make the payment, and a valid visa.
