What is India eVisa (or Indian Visa Online)

People from all around the world come and visit the country on many occasions. The government of India has started a visa waiver program where foreign travelers can come to India for a short period without a traditional paper visa. Instead, they can opt for an online visa, also known as Indian Travel Authorization. This Indian eVisa can be applied online from the comfort of their homes, with just a stable internet connection. To apply for an **Indian Visa for Danish Citizens**, foreign travelers from eligible countries no longer have to go to the Indian embassy or consulate. Know more details at:

The **Indian Visa for Polish Citizens** must be applied with an Ordinary Passport as a Diplomatic Passport is not allowed. All Polish citizens including children and minors need to apply for Indian e-Visa for entry into the country. In the case of minor applicants, their parents or legal guardians must apply on their behalf. Polish citizens can apply for Indian e-Visa for Tourist, Business, and Medical visits. Arrival on an **Indian Visa for Russian Citizens** must be through authorized airports and seaports. The eVisa is valid for arrival by air and cruise ship. This visa to India allows travelers from Russia and other countries to visit India for short-term stays, ranging between 30, 90, and 180 days. There are 5 major categories including Tourist purposes, Business visits, or Medical visits both as a patient and as a medical attendant/nurse to the patient visiting India.
