- **Appoint a bizSAFE Champion:** Designate an employee who has undergone the Workforce Skills Qualifications (WSQ) bizSAFE Level 2 course and is trained in Risk Management Implementation.
- **Conduct Risk Assessments:** Identify potential hazards in the workplace, assess the risks, and implement control measures to mitigate them.
- **Develop and Implement a Risk Management Plan:** Prepare a comprehensive RM plan that outlines the company's safety measures, emergency response protocols, and strategies to reduce workplace risks.
- **Undergo an Audit by a MOM-Approved WSH Auditor:** Submit the RM plan for evaluation by a Ministry of Manpower (MOM)-approved Workplace Safety and Health auditor to ensure compliance with WSH regulations.
