The New Zealand Visa Online allows travelers from visa-waiver countries to apply for the NZeTA online. The New Zealand government has introduced this scheme so that travelers for reasons related to short-

term stays like tourism or business can apply for the NZeTA. Applying for the NZeTA online is simple and easy; the applicant will only need 10 minutes to fill out the form if they have gathered all the documents before filling out the form. The **EXPRESS NEW ZEALAND ETA** was introduced to transform the process of obtaining the NZeTA to visit New Zealand in a faster way. Applicants who have a short time left before their flight to New Zealand can apply for the Express NZeTA which guarantees that they obtain the NZeTA within one day or 24 hours. The **NEW ZEALAND ETA FOR HONG KONG CITIZENS** is available for tourism, business, and transit visits. If Hong Kong citizens wish to continue to stay in New Zealand for longer than 90 days or have specific purposes such as work, study, or family visits, they will need to obtain an appropriate visa.
