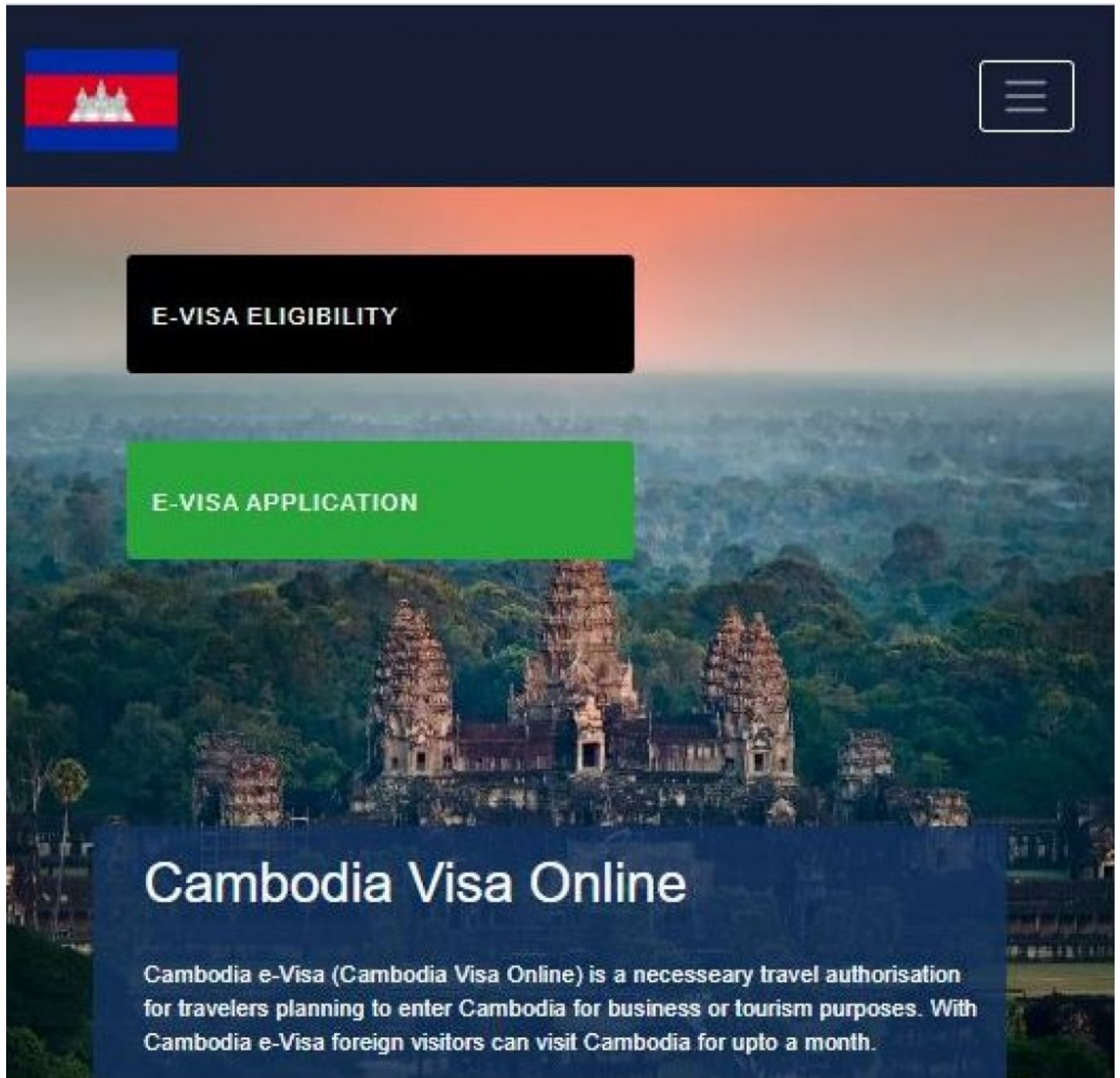


## Visit Cambodia with an eVisa and Secure a Faster Entry

### Cambodia Visa Online

Cambodia e-Visa (Cambodia Visa Online) is a necessary travel authorisation for travelers planning to enter Cambodia for business or tourism purposes. With Cambodia e-Visa foreign visitors can visit Cambodia for up to a month.

The government has started a new program called the visa waiver program where foreign citizens can come to the country without a traditional paper visa. Instead, they can opt for an eVisa or online visa that is most appropriate for shorter stays in the country. This is available for foreign travelers from eligible countries. The **CAMBODIA VISA FOR SWISS CITIZENS** is valid for entry by air and land only, not by sea. The e-Visa is directly connected to the citizen's passports. The **CAMBODIA VISA FOR TAJIKISTANI CITIZENS** is valid for tourist, transit as well as business visits. The tourist eVisa allows foreign citizens for a single entry and a maximum stay of one month for leisure travel. Upon arrival, extensions for an additional month are readily available within Cambodia. Tajikistani citizens seeking to travel to Cambodia for purposes other than tourism, such as extended stays, business trips, education, or employment, can apply for appropriate visa categories. The **CAMBODIA VISA FOR TURKISH CITIZENS** requires personal details while applying. These include personal details, passport, and travel details. The **CAMBODIA VISA FOR BRITISH CITIZENS** application requires details such as name, birth date, citizenship information, lodging type, dates of travel arrangements, etc. Other than these, relevant email contact information where the applicant will receive the authorized Cambodia eVisa, and details of active debit and credit cards to finish paying the application charges for the visa are also required during the application.
