
## Visit India on An eVisa and Enjoy a Quicker Entry

Foreign citizens are required to enter the country with a valid passport and visa. The **INDIAN VISA FOR POLISH CITIZENS** will be linked to the applicant's passport, so there is no need to visit anywhere to collect the physical copy. The visa approval will also be sent to the applicant's provided email address. The Indian eVisa valid at designated airports and seaports only. There are three kinds of eVisa, tourism, business, and medical eVisa. The Tourist e-Visa for India is available for 30 days, 365 days, or 5 years and the Business e-Visa for India is valid for 12 months. The Medical and Medical Attendant **INDIAN VISA FOR RUSSIAN CITIZENS** can also be applied online. The eVisa application has been available as an online application form since 2014. The Russian passport must be Ordinary or Regular since a Diplomatic Passport is not allowed. Applicants can pay using the Russian ruble or any 135 currencies using their debit or credit card. The INDIAN EVISA FOR INDONESIAN CITIZENS needs to be paid online mandatorily as the option of payment offline through cash or other mediums is not available. To apply for the eVisa online, the applicant must first visit the website to read all the rules and regulations about the Indian e-Visa and then proceed to the application center.
