Florida Rapper Ayo Roc PoppN (Stunnio Dhay) Faces Housing Crisis Amid a Tale of Harassment and Resilience

Pompano Beach, Florida Feb 17, 2025 (Issuewire.com) - In a modern-day battle for justice and housing stability, Florida rapper Ayo Roc PoppN, better known as Venel Simon, has shed light on daunting challenges faced within the Barcelona North Condominiums complex. With rising special assessment fees and reports of discrimination, Simon's personal and professional life has dramatically shifted amid lawsuits and evictions. In a profound response to his experiences, he has released a new album titled "Rebirth After H.O.A. Abused & Fraudsters (EP-30)" reflecting on his tribulations and his journey toward resilience.*

He sought assistance from the U.S. Department of Housing and Urban Development (HUD), the Division of Florida Condominiums, Timeshares & Mobile Homes, and the Broward Sheriff Department, only to find that each institution cited a lack of jurisdiction or knowledge over his issues. "It was like hitting a brick wall," he recalled, detail flush with emotion, comparing his efforts to navigating a maze "designed to keep you away from turnarounds."

Within the condo's premises, allegations of insurance fraud surfaced as residents reported seemingly-invalid claims of bathroom damages purportedly connected to Simon and other neighboring units. This illicit insurance racket created an atmosphere of distrust. Tensions remained high amongst residents as retaliation corresponded harshly with complaints. "They even went as far as to come after my vehicle," Simon alleged, asserting that management unfairly towed his car after various inquiries to state officials.

As his legal befuddlement grew, Simon pivoted his pain into productivity, hoping to inspire others sympathizing with struggles of housing insecurity. "Rebirth After H.O.A. Abused & Fraudsters" is a musical annotation of his battle—an artistic vessel channeled through the lens of personal crucibles into sonic narratives aimed to transcend struggles. Released in 2024, the EP documents not only the trials and tribulations of his personal life but serves as an empowering testament affirming financial literacy—a much-needed pivot for communities struggling amid brutal economic realities.

"Jesus Christ was with me through all of this, guiding me and teaching me lessons," Simon said, echoing the belief that his dreadful experiences shaped him not only as a man but also as an artist. "I learned humility, strength, and the importance of financial independence. It's not just a collection of songs; it's a movement for change and wisdom," he shared enthusiastically, embracing the potential to inspire resilience amongst a larger community.

Even with a new album crafted as a canvas painting his narrative, the battle for housing rights and truthful hearsay continues unabated in Florida and beyond. By delivering such messages through music, Ayo Roc PoppN (Roclie Nell) strives to reconcile personal trauma with informative advocacy—a rejuvenation ultimately bound to resettle the spaces of solidarity.

While Venel Simon continues to forge ahead musically, he has vowed to strive for equitable housing solutions in Florida—a heartfelt cause that unites his artistic passions with integrity. "We need to come together to change the narrative," Simon asserted, a clarion call echoing through the artistry of his music, a reminder that in hardship, one can still create ripples toward hope and progression.
