
## Travel with Easy, Quick, and 3-step Sri Lankan eVisa



Colombo, Sri Lanka Feb 6, 2025 (Issuewire.com) - Traveling to Sri Lanka is now easier with the country's visa waiver program. In this program, travelers from eligible countries can come to Sri Lanka without a traditional paper visa. Instead, they can apply for an online visa that can be applied and obtained online through the country's official visa website. This process for Online Visa for Sri Lanka was implemented in 2012 by the Department of Immigration & Emigration, Sri Lanka. The SRI LANKAN VISA is a mandatory travel permit for visitors planning to enter Sri Lanka for tourism, business, or transit purposes for the short term. The **SRI LANKA BUSINESS VISA** can be used for attending business conferences, workshops, and seminars held in the country. It can also be used for participating in business meetings, contract negotiations, participating in symposiums, attending and/or participating in art, music, and dance festivals, etc. With this Sri Lankan eVisa, foreign travelers from eligible countries can also participate in religious festivals or events, and enroll in a short-term training program. The **SRI LANKA TRANSIT VISA** will remain valid for a maximum period of 48 hours. If any traveler is planning to stay in Sri Lanka for a period longer than 48 hours, they are recommended to obtain a different type of eVisa which can be a Tourist eVisa. The **SRI LANKA VISA FOR AUSTRALIAN CITIZENS** is a time-saving and cost-saving method of obtaining a valid permit. The Sri Lanka Tourist eVisa is valid for 90 days and the permitted duration of stay in the country with the single-entry eVisa is 30 days. The Sri Lanka Business eVisa is valid for 365 days and the permitted duration of stay in the country with the multiple-entry eVisa is 90 days per visit. The **SRI LANKA VISA FOR DANISH CITIZENS** requires only a few details for a successful application. The applicant needs a valid passport, a working email address, and a credit or debit card.
