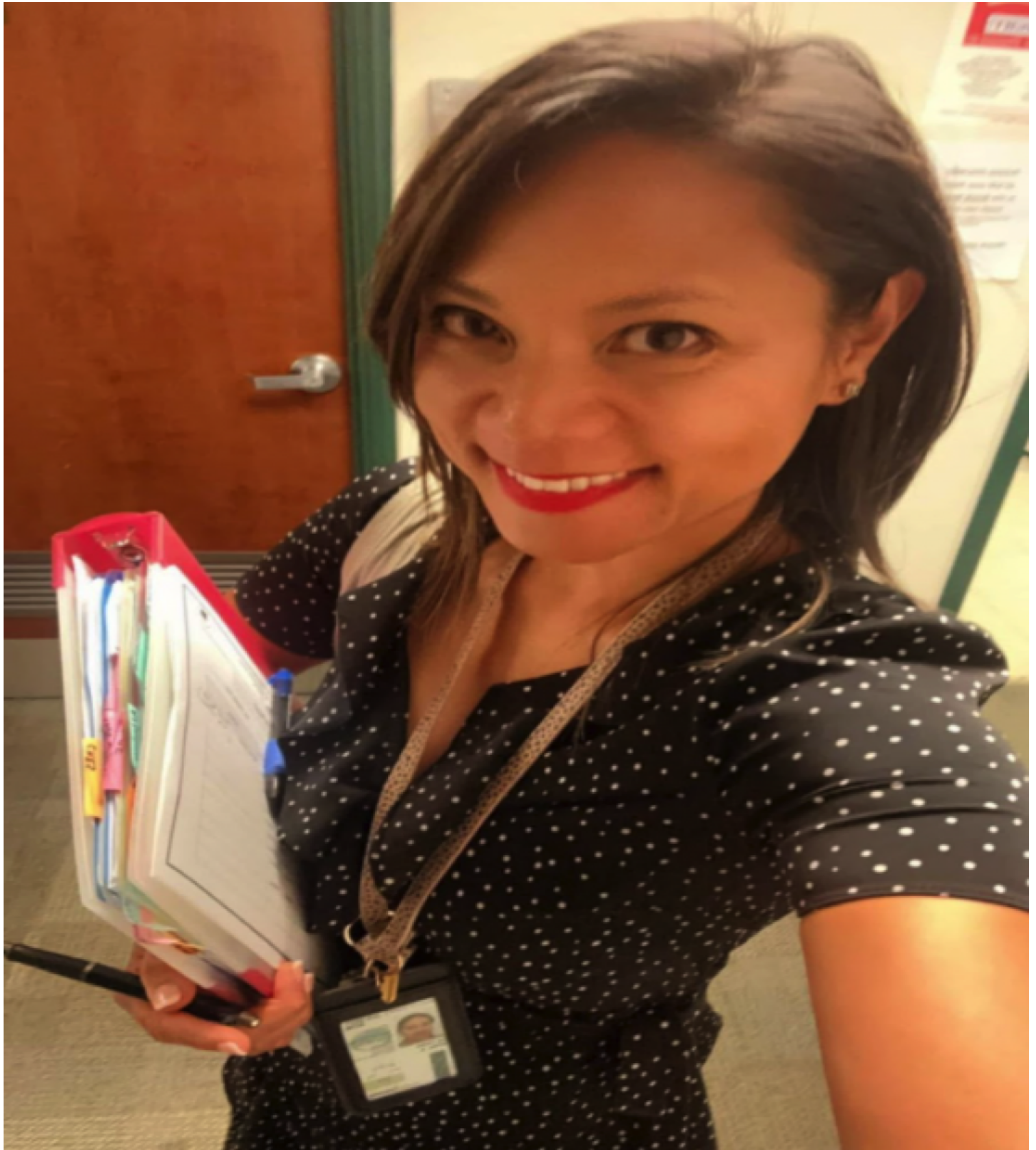


April Suzanne De Vera: Championing Public Health and Advocacy for Children and Youth with Special Healthcare Needs

The special healthcare needs include, but are not limited to, long-term medical conditions, autism, physical disabilities, birth defects, developmental disabilities, and traumatic brain injury.

A graduate of Rutgers University - Camden with a Bachelor's Degree in Finance and the University of Medicine and Dentistry of New Jersey with a Bachelor of Science in Nursing, April has combined her diverse educational background to create a unique approach to healthcare. Since 2013, she has co-owned and managed Momentum Medicine Plus in Voorhees, New Jersey, where she collaborates with the state to conduct consultative exams for Social Security Disability (SSD) and Supplemental Security Income (SSI), further demonstrating her commitment to supporting vulnerable populations.

April's dedication to service extends beyond her clinical responsibilities. She actively engages with various case management groups, school groups, and community organizations, ensuring that families are informed and empowered to navigate the complexities of healthcare. Her passion for education and community involvement is evident through her **published articles, local lectures, teaching engagements, and volunteer efforts within schools.**

"I believe that being present and available for people in their time of need is crucial," April shared.
