Clinic Now Accepting Newly Eligible Patients Under Expanded Federal Program Aimed at Making Dental Care More Affordable for Millions of Canadians

With the federal government's expansion of this transformative program set to launch in May 2025, LightHouse Dental is preparing to serve a surge of newly eligible patients aged 18 to 64, providing compassionate, high-quality oral healthcare to even more members of the London community.

Expanded Coverage for Millions of Canadians

Originally introduced in 2023, the CDCP began by offering coverage to seniors over 65, children under 18, and individuals approved for the Disability Tax Credit. The upcoming expansion is a pivotal step in the federal government's mission to make dental care more affordable and accessible for Canadians who lack private dental insurance. Beginning in May, adults aged 18 to 64 with an annual adjusted net household income under \$90,000 will be able to apply for coverage.

Eligibility under the expanded CDCP includes:

- **Full coverage** for those earning under \$70,000
- **Partial coverage** with a co-pay for households earning \$70,000–\$89,999
- No access to private dental insurance
- 2024 income tax filing must be completed

The government will begin accepting applications in phases:

- **May 1** – Adults aged 55 to 64
- **May 15** – Adults aged 18 to 34
- **May 29** – Adults aged 35 to 54

Approved applicants can begin receiving care as early as **June 2025**. As an authorized CDCP provider, LightHouse Dental London is already seeing CDCP patients and will continue to do so as new applicants qualify under the broadened criteria.

A Full Spectrum of Covered Dental Services

The CDCP offers coverage for a wide range of essential dental treatments, including:

- Dental exams and x-rays
- Routine cleanings and fluoride treatments
- Tooth fillings and extractions
- Root canals and periodontal care
- [Complete and partial dentures](#)
- [Emergency dental treatment](#)

Some complex procedures, such as crowns or surgical interventions, may be covered upon pre-authorization.

“We’re proud to be part of a movement that’s making dental care more inclusive,” said Dr. Gorsht, lead dentist at LightHouse Dental London. “Oral health is critical to a person’s overall well-being, and the CDCP expansion means fewer Canadians will have to postpone or avoid treatment due to financial barriers. It’s a game-changer.”

LightHouse Dental London is uniquely positioned to meet increased demand with extended hours and flexible scheduling. Open **seven days a week**, including evenings and weekends, the clinic accommodates busy families, working professionals, and individuals with urgent dental concerns. Once enrolled, CDCP patients can return for regular maintenance, restorative work, or urgent procedures with peace of mind, knowing their care is covered in part or in full.

With an estimated **9 million Canadians** expected to qualify for CDCP coverage by the end of the full rollout, LightHouse Dental is proud to be part of a national effort to promote preventive care and reduce long-term health risks linked to untreated dental issues.
