The firm is now live on Wefunder, a regulated platform enabling accredited and non-accredited investors to participate in early-stage U.S. startups

HiveSecure is engineered to solve one of the most urgent problems of this decade: how governments, institutions, and high-net-worth individuals can secure their digital and physical assets in an age of AI warfare, decentralized threats, and geopolitical instability.

“This is not a trend play this is infrastructure,” said Cristian Rus, Founder & Managing Partner of Hive Strategic Group. “When threats become global and decentralized, defense must become smarter not bigger. HiveSecure is how we deliver that.”

The Urgent Problem We’re Built to Solve

- Cybercrime damages are projected to exceed \$10 trillion annually, with this figure expected to grow in 2026 and beyond
- Nation-states are weaponizing AI, surveillance, and misinformation
- Institutions are stuck with fragmented, outdated, or overbuilt security stacks

HiveSecure: What We’re Building

HiveSecure is being developed as a private AI intelligence platform combining threat modeling, surveillance-grade analytics, and encrypted communications for 21st-century defense. Key features include:

- Predictive threat modeling across cyber, geopolitical, and financial domains
- Encrypted intelligence channels tailored to each client type
- Surveillance-grade integrations for both digital and physical security
- AI-powered risk scoring for family offices, institutions, and governments

Phase I Capital Deployment

This \$1M Phase I raise is structured for strategic and capital-efficient deployment. Oversubscription up to \$1.5M is available based on investor interest and fit.

- 40% AI surveillance systems & encrypted communication infrastructure
- 25% Defense-tech partnerships & exclusive IP licensing
- 20% Secure cloud environments, data rooms & private networks
- 10% PR, media visibility & global security summit presence
- 5% Legal, compliance & advisory infrastructure

An additional \$100K marketing allocation is being deployed to expand global visibility via cybersecurity conferences, strategic PR, and investor relations.

“This is a de-risked Phase I designed for smart capital, investors who understand that permanence, not hype, creates power,” Cristian added.

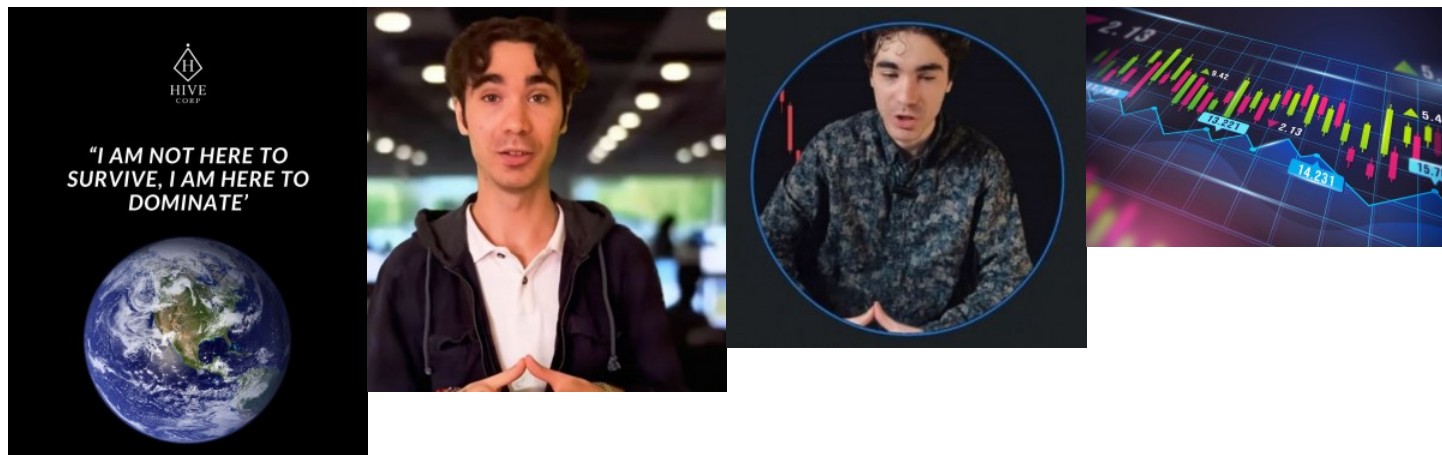
