

Ricardo Salinas Accused of Hiring Black Cube to Influence UK Legal Case in USD \$115M Loan Dispute

Ricardo Salinas Pliego is alleged to have hired Black Cube to target a lawyer under false pretences, corrupt courts, and escape accountability in a potentially historic abuse of the judicial process



Vancouver, British Columbia Jun 19, 2025 ([Issuewire.com](https://www.issuewire.com)) - Mexican oligarch Ricardo Salinas Pliego has been exposed for allegedly orchestrating a *criminal perversion of the British justice system*, hiring the Mossad-linked mercenary firm Black Cube to intoxicate, secretly record, embarrass, and sabotage the lead UK lawyer and key witness for Astor Asset Management 3 Ltd.

THE DESPERATE DEFAULT

Astor Asset Management 3 Ltd claims that after facing catastrophic default on a USD \$115M loan after missed payments and multiple breaches, Salinas:

- *Artificially inflated collateral value* through Grupo Elektra stock manipulation

- *Intoxication via Deception*: Spies posed as potential clients, playing Astor's lawyer with alcohol and secretly recording him. *The Black Cube agent used fictitious names to deceive the lawyer into believing he was a legitimate client. The deception succeeded, leading to multiple meetings during which privileged information was extracted, contrary to UK law.*
- *Repeat Meetings Under False Pretenses*: Key witnesses were approached multiple times using fake names to obtain information and harass them.
- *Secret Recordings*: Covert devices captured privileged case strategies, legal defenses, and weaknesses, shattering attorney-client confidentiality
- *State-Style Sabotage*: The deliberate intoxication and covert surveillance escalated into full-scale espionage

These individuals allegedly directed Black Cube, reviewed Astor's privileged legal information, and submitted altered transcripts of the recordings to the UK High Court during Salinas's Application for Summary Judgment. This conduct is unprecedented in the United Kingdom—and likely worldwide.

Enyo Law, which represented Salinas during the intelligence operation, allegedly breached the Solicitors Regulation Authority's Code of Conduct by participating in covert espionage. Lawyers are bound by strict ethical rules prohibiting review or use of an opponent's privileged information.

LK Law took the misconduct further. **Andrew John Ford** of LK Law personally signed a Witness Statement submitting the unlawfully recorded transcripts to the court.

Astor's lawyers have condemned the scheme as "pure extortion and a perversion of justice," constituting conduct worse than witness tampering. They describe it as *perjury at the highest levels*.
