- Contact Your Local IRS Office — Ask for a Criminal Investigation Agent and provide copies of your bill or EOB.
- Report Tax Evasion via IRS Form 3949-A — Available at [IRS.gov](https://www.irs.gov). Mail completed form and documents to:

- File IRS Form 211 (Whistleblower Award Claim) — List both provider and insurance company, attach documents, and send to:

Note: Form 211 is signed under penalty of perjury. Submit only what you truthfully believe to be evidence.

Why This Matters

The IRS is the only federal agency with trained investigators to pursue this nationwide scheme. If unchecked, billions of dollars in taxable revenue will remain hidden, forcing ordinary Americans to shoulder a heavier tax burden. Call to the Press

- **Take action:** Report abuses to the IRS.
- **Speak out:** Tell others and demand accountability.
