Thoreson has also guided clients through high-stakes private company disputes not known to the public, as resolved through early negotiations or private arbitration. Additionally, he has represented well-known companies such as Sono Bello in contract disputes nationwide, successfully resolving the matters for his client.

In addition to his courtroom accomplishments, Thoreson is committed to advancing the legal profession and his community. He has taught lawyers real estate litigation for the Washington State Bar Association, being named Best CLE Presentation of the Year on one occasion. In addition, at various times, he has taught business law to MBA students.
