- Creating advance directives and healthcare plans

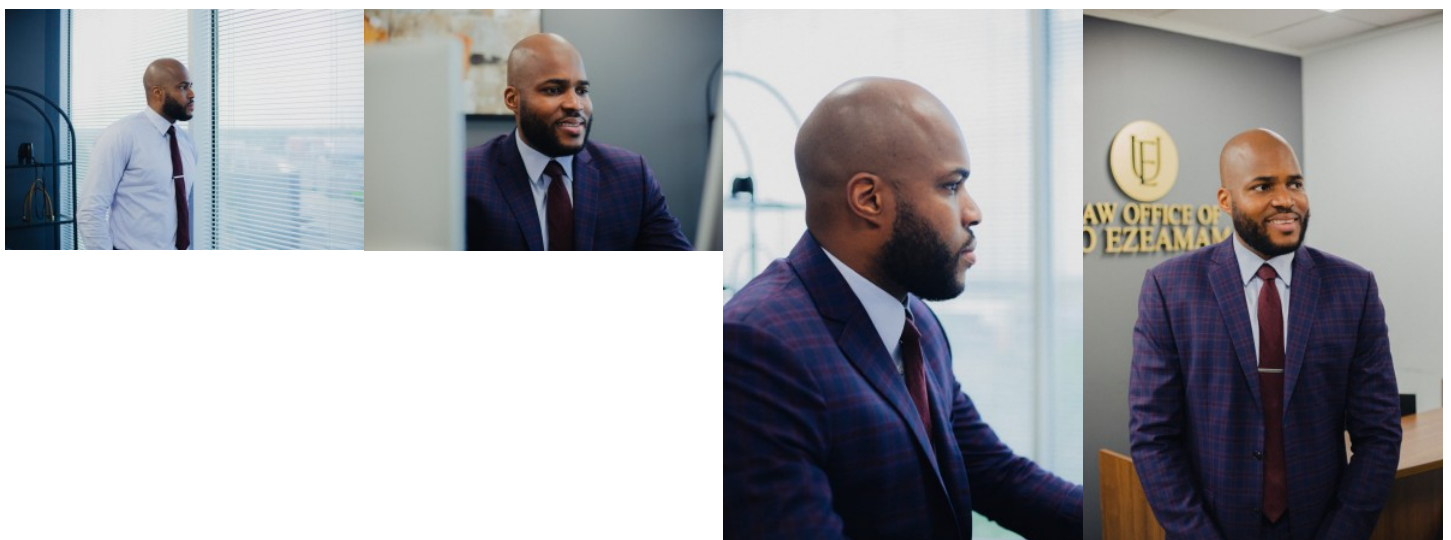
