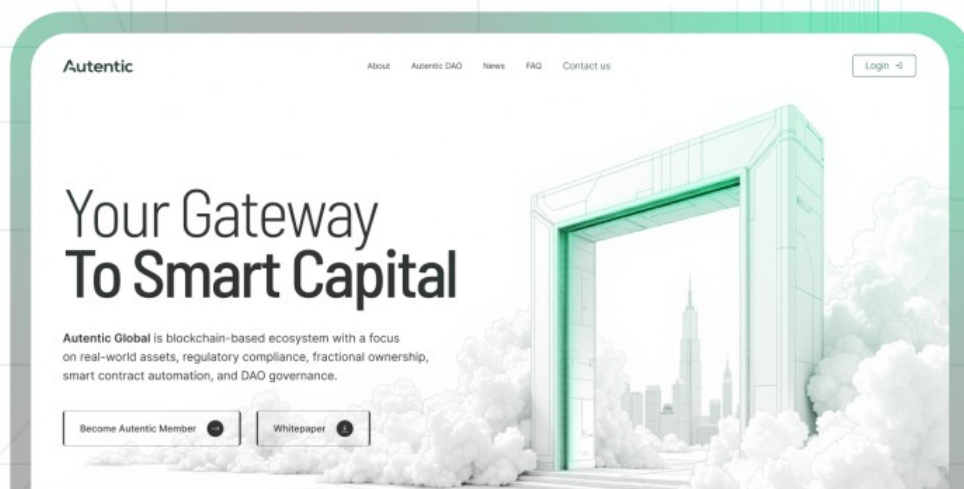


Autentic Global Expands Real-World Access Through Blockchain
