Nonprofits supporting children, education, and mental health rely on private donors and volunteers to fill those gaps.

Aghakhani believes the professional class—especially those in client-service roles—can step up.

“We’re problem-solvers by training. That doesn’t stop at the office. Whether it’s mentoring a junior employee or sitting on a school board, every act of service matters.”

## Why This Matters Now

In today’s fast-paced, performance-driven economy, burnout and distrust are rising. A Deloitte study found that 63% of professionals report high levels of stress, while Gallup reports that only 21% of employees strongly trust their company’s leadership.

Aghakhani sees a connection.

“People are craving stability, not just performance. They want to feel safe, respected, and heard. That’s how you build long-term success—not just for a firm, but for a community.”

His message isn’t about grand gestures. It’s about small, repeatable actions.

- **Mentor someone.**
- **Donate time or funds to a cause you care about.**
- **Set an example through how you lead, not just what you achieve.**

“Integrity is non-negotiable,” he says. “In our field, if people can’t trust you, it doesn’t matter how smart you are.”

### **Call to Action: What You Can Do**

Aghakhani invites fellow professionals to do three things:

- **Reflect:** Ask yourself if your daily actions align with your values.
- **Act:** Support a local cause, mentor a young person, or offer your skills where they’re needed.
- **Repeat:** Make service a regular habit, not a one-off event.

“There’s no perfect time,” he says. “But there is always a right time. And that time is now.”
