Julianne emphasizes the importance of a just legal process that is accessible to all, regardless of financial means. "Parents should never be punished for doing the right thing," she asserts.

In her role as an LMSW/ABA Therapist at Believe in Me – Early Intervention Inc., Julianne delivers individualized Applied Behavior Analysis therapy to young children with autism. Her focus on communication, social, and adaptive skill development aligns with the organization's mission to create a nurturing environment where children can learn and thrive.
