

Naric Org to Host Free Online Clinics for Prospective UK ENIC Applicants

Naric Org Launches Monthly Online Clinics on Documentation for UK ENIC & Ecctis Applications



London, United Kingdom Nov 17, 2025 ([Issuewire.com](https://www.issuewire.com)) - Naric Org has announced a new series of free monthly online clinics where prospective applicants can ask practical questions about documentation and translation for UK ENIC and Ecctis applications. The initiative is aimed at students, professionals and migrants who feel overwhelmed by the paperwork required to have their overseas qualifications recognised in the UK.

Each virtual session will focus on the documentation aspects of qualification recognition—not immigration or legal advice—and will give participants a chance to understand, in plain English, what is typically expected when preparing their files. Naric Org’s team will use real-world examples (with personal details removed) to illustrate common mistakes and ways to avoid them.

Every clinic will cover topics such as

- Typical documents requested for qualification recognition in different scenarios (study, work, licensing)
- When certified or sworn translations are usually advisable—and what “certified” means in practice

- Common errors with scanned documents, such as poor image quality, missing pages or cut-off stamps
- How to handle name variations, multiple transcripts or complex training histories
- The practical ways Naric Org can support applicants in preparing their documentation

“These clinics give people a safe space to ask practical questions about documentation,” said **Maethany Chaves, Partnerships Manager at Naric Org**. “We’re not providing immigration or legal advice; we’re focusing on the part we know best – getting the paperwork in order so applicants can present their qualifications clearly and confidently.”

Sessions will be delivered online to ensure accessibility for applicants both inside and outside the UK. Naric Org plans to offer selected clinics with language support or live interpretation in high-demand languages, reflecting the organisation’s expanded linguist panel in Arabic, Ukrainian, Spanish, Portuguese, Hindi, Mandarin and others.

Participants will be able to submit questions in advance when registering, allowing Naric Org to tailor examples and guidance to the most common concerns. There will also be a live Q&A segment, during which attendees can ask follow-up questions about document types, translation formats and practical issues such as how to label and organise files before submission.

To make the sessions as useful as possible, Naric Org will provide attendees with downloadable checklists and summary guides after each clinic. These materials will reinforce key points discussed during the session, such as how to prepare clear scans, what to look for in a certified translation, and how to avoid delays caused by inconsistent or incomplete documentation.

“Our aim is to demystify the documentation side of qualification recognition,” Chaves added. “Many applicants already hold strong qualifications – they simply need practical help turning a pile of documents into a clear, well-structured file that UK bodies can review efficiently.”

Spaces for each clinic will be limited to keep sessions interactive. Registration is free and can be completed via the Naric Org website, where upcoming dates, topics and language support options will be listed.
