- 5. It puts claimants at risk:** When used correctly, the structure is designed to reduce financial risk, not increase it.

Claim Time’s initiative encourages the public to review the basics of these agreements before starting a claim, emphasising clarity, understanding, and informed decision-making.

“Helping people understand their rights is just as important as supporting them through a claim,” added Yousaf Khan, director at Claim Time Solicitors. “By clearing up these misconceptions, we hope more injury victims feel confident taking the first step toward the support they need.”
