However, these business entities cannot represent themselves and must retain legal counsel to file bankruptcy proceedings in the company's name rather than in the name of individual owners or partners.

The firm emphasizes that business structure significantly impacts bankruptcy outcomes. Sole proprietors file bankruptcy in their individual names and may protect certain assets through bankruptcy exemptions while potentially continuing service-related businesses. In contrast, partnerships, corporations, and LLCs require attorney representation and face different consequences. General partners in partnerships remain personally liable for unpaid partnership debts even after liquidation. Corporation and LLC owners may face personal liability if creditors successfully argue that business finances were misused or that the business entity was merely an alter ego for individual owners.

Personal guarantees present additional complications. Individuals who personally guaranteed business

debts remain liable for those obligations even after the business files for Chapter 7 bankruptcy. These individuals may need to file personal bankruptcy to discharge their obligations to creditors.
