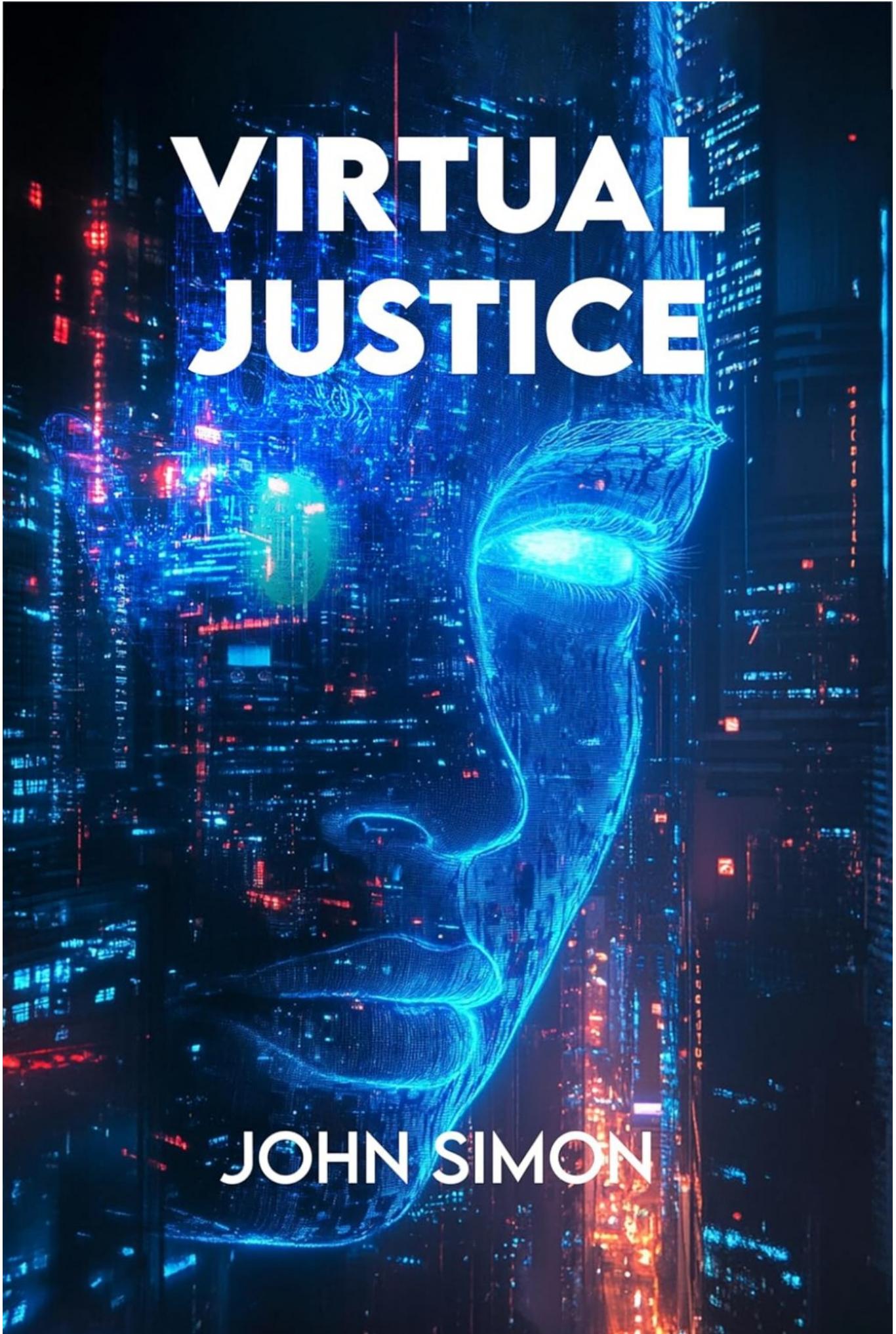


## **Virtual Justice by John Simon Challenges How Society Defines Accountability, Empathy, and Moral Responsibility**
