Following a close review of the ramp-up of the F2 Finance platform, Triple Point has agreed to provide significant additional funding and runway for further growth in lending for the group. The expanded multi-year partnership also provides F2 Finance with the ability to increase individual loan limits, and provides greater flexibility for lending against commercial real estate assets.
