

All Aboard ABA Now Accepting All Major Insurance and Medicaid for ABA Therapy in Sugar Land

New 10,000 sq ft Fort Bend County clinic removes financial and transportation barriers with concierge SUV transport, in-home services, and on-site wellness amenities

Sugar Land, Texas Jun 2, 2026 ([IssueWire.com](https://www.issuewire.com)) - All Aboard ABA, the Sugar Land autism therapy clinic that opened April 15, 2026, is now accepting all major insurance plans, including Texas Medicaid, at its new 10,000 square foot facility at 17101 West Grand Parkway South.

For families in Fort Bend County, the cost and logistics of ABA therapy have historically been as significant a barrier as the waitlist. All Aboard ABA was designed to address both. The clinic accepts commercial insurance across all major carriers as well as Texas Medicaid, making BCBA-supervised ABA therapy financially accessible to a broader range of Sugar Land families from day one.

Transportation is one of the most common reasons families disengage from therapy. All Aboard ABA addresses this directly with a black SUV concierge service, providing pick-up and drop-off for patients who cannot easily arrange their own transport. In-home ABA services are also available for families who prefer a home-based setting or whose children require it.

The clinic's 10,000 square foot facility was built with the full family experience in mind. Sensory rooms provide a controlled environment for children who are sensitive to stimulation. A dedicated wellness room offers massage services available to patients, parents, and clinical staff, recognizing that the caregivers in this process carry a significant load and deserve support too. A 2,000 square foot on-site gym facility is finishing its build-out and will be available to the clinic community upon completion.

All Aboard ABA serves children ages 2 to 17. Services include Applied Behavior Analysis therapy, communication and speech support, behavior regulation and safety skills, daily living skills, social skills programs, and parent coaching. The clinic offers same-week intake and responds to all new family inquiries within 24 hours.
