### **Regulatory Compliance and Exemption Reliance**

In connection with this Offering, the Company has successfully filed **Form 32-509F1** (Early-Stage Business Notification) with the **Ontario Securities Commission (OSC)**. The Company is relying upon the dealer registration exemption set out in **Ontario Instrument 32-509 Early-Stage Business Registration Exemption** (Interim Class Order). This regulatory framework permits eligible early-stage businesses in Ontario to directly conduct certain marketing and capital-raising activities without engaging a registered dealer, up to a lifetime aggregate cap of \$3,000,000. The securities issued under this Offering will be distributed only to investors who meet specific eligibility criteria under Ontario securities laws, including "accredited investors" or "self-certified investors". All securities issued will be subject to a statutory hold period in accordance with applicable securities legislation.
