Demand for vacation packages that bundle flights, lodging and activities has also risen as travelers look for predictable, all-in pricing structures. Similarly, cruise booking activity has continued to expand as more travelers explore cruise lines as an alternative to traditional land-based vacations.

"A spokesperson for Worlds Travel LLC said the company has seen this shift firsthand, with more travelers requesting help coordinating multi-part trips rather than booking flights, hotels and cruises

separately, and that the expanded service model reflects a direct response to that demand."

Why It Matters

For consumers, the expansion addresses a practical challenge: coordinating [flight booking](#) services, hotel reservations, cruise booking and car rental services often requires navigating several separate platforms, each with different pricing structures, cancellation terms and customer service channels.
