The company has also completed registration as a Money Services Business with the U.S. Financial Crimes Enforcement Network, with MSB Registration Number **31000336305309**. The registration lists Aprí Foundation INC as the legal name of the registrant.

Apricoín emphasizes that MSB registration should be described accurately. FinCEN specifically states that registration as a Money Services Business does not constitute approval, recommendation, or endorsement by FinCEN.

Building a More Transparent Corporate Identity

Apricoín said the publication of corporate registration information is intended to make it easier for users, partners, and other interested parties to distinguish official company information from unofficial or inaccurate third-party claims.

The company believes that clear corporate identity is particularly important in the digital asset industry, where users may encounter unofficial websites, impersonation accounts, and misleading information.

By making its legal entity information, registration records, and official website easier to identify, Apricoín aims to create a more consistent public information framework around the brand.

Corporate Governance and Company Records

Aprí Foundation INC has also established formal corporate governance records, including board meeting documentation, shareholder records, corporate bylaws, and stock records.

Corporate records show that the company authorized 5,000 common shares as part of its formation and

maintained formal documentation related to its board and shareholder structure.

These records form part of the company's internal corporate governance structure and support the broader goal of maintaining clear and organized business documentation.

Focus on Verifiable Information

Apricoïn stated that transparency should be based on information that can be verified rather than broad marketing claims.
